4G trials: BSNL objects to deviations proposed by TCS

A TATA CONSULTANCY Services (TCS)-led consortium selected by BSNL to do trials for testing their 4G equipment, has proposed 128 deviations in product specifications, which the state-run telco thinks, if accepted, could jeopardise its business prospects and impact customer experience. BSNL has written to the department of telecommunications seeking to know whether to accept the deviations or not.

According to BSNL, the deviations proposed by TCS include a few critical issues and cannot be compromised for testing of the equipment being proposed under proof of concept (PoC) or trials as the same equipment has to be deployed in 4G commercial network immediately after the trials.

But as BSNL on its own can't reject or accept the deviations, it has asked DoT for guidance. "According to this office, accep-

tance of such deviations will cost BSNL in future once the rollout happens and it will not only jeopardise the interests of BSNL's business prospects but also adversely impact the customer experience as well as BSNL's competitive strength," BSNL CMD PK Purwar has said in a letter to telecom secretary Anshu Prakash, a copy of which has been seen by *EE*.

The CMD said in such a situation, the financial position of BSNL may further deteriorate and the objective framed by the government under the revival plan may not be achieved fully.

TCS has proposed 18 deviations in core, 71 in radio network, 6 in interworking, 13 in deferred core and 20 in deferred radio network.

It must be mentioned that the TCS-led consortium is the most promising candidate to develop the 4G solution to roll-out BSNL's indigenous network. TCS has partnered with C-DoT for core network and Tejas and Altiostar for radio equipment and will conduct the trials at Chandigarh. Tech Mahindra, HFCL, L&T and ITI have also been selected to do trials.

Trials are necessary because BSNL has been mandated to use equipment from local firms only for its core network as part of what is called a system integrator-led model.

BSNL said as other bidders have not submitted any deviation statement, it is assumed their product meets specifications and is ready for commercial deployment. "It is earnestly requested that the deviations submitted by TCS may be deliberated upon by DoT and suitable advice/guidance be provided to BSNL so as to enable BSNL to accomplish the PoC in a time-bound manner," the letter said.

DoT engages with banks to resolve telecom stress

THE DEPARTMENT OF Telecommunications (DoT) has initiated discussions with banks to address financial stress in the telecom sector, particularly Vodafone Idea, which needs

fund infusion to stay afloat. DOT officials and senior bankers met to discuss the VIL issue on Friday, sources said, adding that banks have been asked to look for a solution

within the prudential guidelines. According to sources, senior officials from State Bank of India and Bank of Baroda, were present, among others, for the meeting. —PTI

परमबीर सिंह खंडणीप्रकरणी दोघांना पोलिस कोठडी

ठाणे, दि. ८ (वार्ताहर) : माजी पोलिस आयुक्त परमबीर सिंह, सुनील जैन आणि संजय पुनामिया यांच्यासह पाच जणांविरुद्ध सुमारे पाच कोटी रुपयांची खंडणी उकळल्याचा गुन्हा कोपरी पोलिस ठाण्यात दाखल आहे. यातील सुनील आणि संजय या दोघांचा ताबा मुंबई पोलिसांकडून ठाणे पोलिसांना मिळाला आहे. या दोघांना शनिवारी ठाणे न्यायालयात हजर केल्यानंतर त्यांना १२ ऑगस्टपर्यंत पोलिस कोठडी सुनावण्यात आली आहे. परमबीर सिंह हे ठाणे पोलिस आयुक्त असताना २०१८ मध्ये यूएलसी घोटाळ्याप्रकरणी एका बांधकाम व्यावसायिकाला ठाणे पोलिसांनी अटक केली होती. त्यांच्याविरुद्धातील मोठ्या कायद्यांतर्गत होणारी कारवाई टाळण्यासाठी परमबीर सिंह, ठाणे गुन्हे अन्वेषण शाखेचे तत्कालीन उपायुक्त परम मणोर, सुनील जैन, संजय पुनामिया, मनोज घोटेकर यांनी ४ कोटी ६८ लाख रुपयांची खंडणी उकळल्याचा आरोप बांधकाम व्यावसायिकाच्या पुढण्याने केल्यानंतर याप्रकरणी कोपरी पोलिस ठाण्यात गुन्हा दाखल करण्यात आला होता. काही दिवसांपूर्वीच सुनील आणि संजय यांना एका खंडणीच्या प्रकरणात मुंबई पोलिसांनी अटक केली होती. कोपरी पोलिसांनी शुक्रवारी सुनील आणि संजय या दोघांचा ताबा मुंबई पोलिसांकडून घेतला. त्यांना न्यायालयाने त्यांना १२ ऑगस्टपर्यंत पोलिस कोठडी सुनावली आहे.

न्यायाधीशांवरच हक्कासाठी न्यायालयात जाण्याची वेळ

मुंबई, दि. ८ (प्रतिनिधी) : राज्याचा सार्वजनिक बांधकाम विभाग दुर्लक्ष करत असल्यामुळे मुंबई आणि उर्वरित महाराष्ट्रात कनिष्ठ न्यायाधीशांना देण्यात आलेली अधिकृत निवासस्थाने दयनीय स्थितीत असल्याचा आरोप 'महाराष्ट्र जजसे असोसिएशन'ने याचिकेद्वारे उच्च न्यायालयात केला आहे. मुख्य न्यायमूर्ती दीपांकर दत्ता आणि न्यायमूर्ती गिरीश कुलकर्णी यांच्या खंडपीठासमोर नुकतीच या याचिकेवर सुनावणी झाली. त्या वेळी अधिकृत निवासस्थानाच्या संदर्भात मुंबई आणि राज्यातील उर्वरित न्यायालयीन अधिकाऱ्यांना भेडसावणाऱ्या विविध अडचणी असोसिएशनच्या वतीने अॅड. तेजस दंडे यांनी न्यायालयासमोर मांडल्या. याचिका करण्यापूर्वी असोसिएशनने या निवासस्थानांची पाहणी केली व न्यायालयीन अधिकाऱ्यांकडून निवासस्थानाबाबतच्या समस्या जाणून घेतल्याचेही सांगण्यात आले. तसेच यासंदर्भातील तक्रारीसाठी न्यायाधीशांना ऑनलाईन व्यासपीठ उपलब्ध करण्याचे आदेश द्यावेत, अशी मागणी याचिकेत करण्यात आली आहे. याबाबतचे मुख्य न्यायमूर्तीकडे निवेदन करण्याची सूचना खंडपीठाचे असोसिएशनला केली. पुणे येथील न्यायाधीशांनी या पाहणीच्या वेळी सांगितले की, त्यांच्या शौचालयाचे छत गळत आहे. बाजार तक्रार करूनही सार्वजनिक बांधकाम विभागाने त्याची दुरुस्ती केलेली नाही. परिणामी शौचालयात जाताना छत्री घेऊन जावी लागते. माझगाव येथील इमारतही धोकादायक स्थितीत माझगाव येथील न्यायाधीशांच्या 'गुलमोहर' इमारतीतील काही घरांच्या गच्च्यांचे भाग गेल्या वर्षी पावसाळ्यात कोसळले होते. या दुर्घटनेमुळे कोरोनाच्या काळातही न्यायाधीशांच्या कुटुंबीयांना अन्य ठिकाणी हलवण्यात आले. ही इमारत ३० वर्षे जुनी असून मोडकळीस आलेल्या स्थितीत आहे. यावरून या इमारतीच्या बांधकामाचा दर्जा दिसून येतो. इमारतीतील बहुतांश न्यायाधीशांनी घराची गच्ची धोकादायक असल्याच्या तक्रारी केल्या. मात्र सार्वजनिक बांधकाम विभागामुळे त्याला काहीच प्रतिसाद देण्यात आला नाही, असा आरोपही याचिकेत करण्यात आला आहे.

विमानतळासमोरील उड्डाणपुल रद्द शहराला मिळणार एकच अखंड उड्डाणपुल - खासदार इम्तियाज जलील

औरंगाबाद, दि. ८ (वार्ताहर) : केंद्रीय मंत्री नितिन गडकरी सोबत यशस्वी चर्चा, एका महिण्यात सर्वेक्षण करून तांत्रिक अहवाल सादर करण्याचे आदेश जारी खासदार इम्तियाज जलील यांनी आज सुभेदारी गेस्ट हाऊस येथे पत्रकार परिषद घेवून सर्वसामान्य जनतेची प्राथमिकता तसेच औरंगाबाद व औद्योगिक क्षेत्राच्या विकासाच्या दूरदृष्टीने अत्यंत महत्त्वपूर्ण असलेल्या प्रिंटावेल चौक ते चिकलठाणा पर्यंतच्या अखंड उड्डाणपुलाला रस्ते वाहतूक व महामार्ग केंद्रीय मंत्री नितिन गडकरी यांच्या सोबत दिल्ली येथे यशस्वी बैठकीमध्ये मान्यता मिळाल्याची माहिती दिली. केंद्रीय मंत्री नितिन गडकरी यांनी चिकलठाणा विमानतळासमोरील उड्डाणपुल रद्द करून अखंड उड्डाणपुलाकरिता एका महिण्यात तज्ञ एजन्सीकडून सर्वेक्षण होवून अहवाल सादर करण्याचे निर्देश दिले. केंद्रीय मंत्री नितिन गडकरी यांच्या सोबत बैठकीत झालेल्या चर्चेची सविस्तर माहिती खासदार इम्तियाज जलील यांनी पत्रकार परिषदेत दिली. औरंगाबादमध्ये चिकलठाणा व प्रिंटावेल चौकाला जोडणारा एकच मोठा व अखंड उड्डाणपुल बनू शकतो ज्यामुळे शहरातील सर्वात महत्त्वाच्या रस्त्यावरील वाहतूक कोंडी कमी होईल, यासंदर्भात झालेल्या बैठकीनंतर लवकरच काम होणार असल्याचे आश्वासन केंद्रीय मंत्री नितिन गडकरी यांनी दिले. सदरील बैठकीत जालना रस्त्यावरील सध्याच्या कामावर सुध्दा सविस्तर चर्चा करण्यात आल्याची माहिती पत्रकार परिषदेत खासदार इम्तियाज जलील यांनी दिली. खासदार इम्तियाज जलील यांनी विमानतळासमोरील उड्डाणपुलाबाबतच्या आपल्या आक्षेपाबद्दल केंद्रीय मंत्री नितिन गडकरी यांना सविस्तर माहिती दिली आणि त्यांना सांगितले की इतर लोकप्रतिनिधी आणि सरकारी अधिकाऱ्यांनीही असाच आक्षेप घेतला आहे. नितिन गडकरींनी जालना रस्त्यावरील नकाशाचा आढावा घेतल्यानंतर विमानतळासमोरील उड्डाणपुल रद्द करण्याच्या सूचना दिल्या आणि विमानतळ ते थेट प्रिंटावेलला जोडणारा एक मोठा उड्डाणपुल करण्याचे मान्य केले. नितिन गडकरी यांनी जालना रोड उड्डाणपुलांचे संपूर्ण डिझाईन चुकीच्या पद्धतीने केल्याबद्दल खंत व्यक्त केली आणि ते म्हणाले की, यापूर्वीच्या लोकप्रतिनिधी आणि अधिकाऱ्यांकडे भविष्यासाठी ह्प्टी नसल्याने हे घडले. जालना रस्त्यावरील विद्यमान उड्डाणपुल तांत्रिक सुधारणांद्वारे कसे जोडले जाऊ शकतात हे पाहण्यासाठी केंद्रीय मंत्री नितिन गडकरी यांनी त्यांच्या संबंधित अधिकाऱ्यांना तज्ञ एजन्सीकडून सर्वेक्षण करण्याचे निर्देश दिले. मात्र राज्य सरकार आणि विशेषतः महानगरपालिकेला शक्य तिथे जमीन उपलब्ध करून देण्यासाठी सहकार्य करावे लागेल असे ही ते म्हणाले. खासदार इम्तियाज जलील यांनी मंत्र्यांकडे तक्रार केली की जेव्हा पुणे, नाशिक, नागपूर आणि अहमदनगर सारख्या इतर शहरांना मोठे उड्डाणपुल दिले गेले आहेत तेव्हा औरंगाबादला सावत्रतेची वागणूक का दिली जात आहे? नितिन गडकरींनी बैठकीत त्यांच्या मंत्रालयाने पुणे आणि औरंगाबादला डबल डेकर फ्लायओव्हरद्वारे जोडण्याच्या निर्णयाची माहिती हि खासदार इम्तियाज जलील यांना दिली.

कस्तुरबा रुग्णालयात वायुगळती

मुंबई, दि. ८ (प्रतिनिधी) : सातरस्ता येथील कस्तुरबा रुग्णालयात शनिवारी दुपारी १२ वाजण्याच्या सुमारास वायू (एलपीजी) गळती झाल्यामुळे ५८ रुग्णांचे अन्यत्र स्थलांतर करण्यात आले. तेथील १९ कर्मचाऱ्यांनाही तातडीने बाहेर काढून अग्निशमन दलाच्या जवानांनी वायुगळती नियंत्रणात आणली.

स्वयंपाकाच्या वायूची गळती होत असल्याचे शनिवारी दुपारी १२च्या सुमारास रुग्णालय प्रशासनाच्या निदर्शनास आले. त्यानंतर तेथून जवळच असलेल्या रुग्णकक्षात काविळीचे ४६ आणि अन्य आजारांचे काही रुग्ण दाखल होते, तर जवळच्या इमारतीमध्ये २० कोरोना रुग्णांवर उपचार सुरू होते. वायुगळतीची माहिती मिळताच अग्निशमन दलाचे चार बंब आणि पालिकेच्या आपत्कालीन व्यवस्थापन विभागाचे कर्मचारी रुग्णालयात दाखल झाले. त्यांनी रुग्णालयातील ५८ रुग्णांचे अन्य इमारतीत स्थलांतर केले.

वायुगळती झालेल्या भागातून कोरोनाबाधितांना विशेष दक्षता घेऊन अन्य ठिकाणी दाखल करण्यात आले आहे. प्राणवायूची गरज असलेल्या एका रुग्णाला सध्या अतिदक्षता विभागात दाखल केले आहे. सर्व रुग्णांची प्रकृती स्थिर आहे, अशी माहिती अतिरिक्त आयुक्त सुरेश काकाणी यांनी दिली. रुग्णालयाच्या जवळपासच्या इमारती, चाळींमधील रहिवाशांना घरातून बाहेर येण्यास सांगितल्यामुळे दुपारी या परिसरात गोंधळ आणि भीतीचे वातावरण निर्माण झाले होते. महापौर किशोरी पेडणेकर यांनीही रुग्णालयाला भेट देऊन दुर्घटना आणि बचावकार्याचा आढावा घेतला. भारतीय जनता पक्षाचे मुंबई अध्यक्ष आमदार मंगल प्रभात लोढा, दक्षिण मुंबई जिल्हा अध्यक्ष शरद चिंतनकर व स्थानिक नगरसेविका सुरेखा लोखंडे, भायखळा विधानसभा अध्यक्ष नितिन बनकर यांनी कस्तुरबा रुग्णालयात शनिवारी पाहणी केली. या घटनेस जबाबदार असणाऱ्या संबंधित प्रशासकीय अधिकार्यांवर कठोर कारवाई व्हावी यासाठी आग्नीपाडा पोलिस ठाणे येथे तक्रार दाखल केली आहे. नियंत्रणासाठी सहा तास वायुगळती होत असलेल्या ठिकाणी तात्पुरता उपाय करून

गळती नियंत्रणात आणली आहे; परंतु गळती पूर्णपणे थांबविण्यासाठी दुरुस्ती करणे गरजेचे आहे. त्यामुळे गळती नियंत्रणात आली असली तरी अग्निशमनदलाचे दुरुस्तीचे काम उशिरापर्यंत सुरू होते. म्हणून धोका टळला! रुग्णालयाच्या आवागत इंधनाचा वायू साठवण्यासाठी १० मेट्रिक टनची टाकी (शेल) आहे. या टाकीमध्ये तांत्रिक बिघाड झाल्यामुळे मोठ्या प्रमाणावर गळती सुरू झाली; परंतु अग्निशमन दलाने रुग्णालयाचा परिसर तातडीने रिकामा केला. सर्व बाजूंनी कुंपण उभारण्यात आले आणि टाकीजवळ कोणी येणार नाही याची दक्षता घेतली. तसेच हवा खेळती ठेवून गळती झालेल्या वायूचा निचरा होऊ देण्यात आला. त्यामुळे धोका टळला, असे उपप्रमुख अग्निशमन अधिकारी हेमंत परब यांनी सांगितले.



शुल्करचनेतील हस्तक्षेपास मंत्र्यांचाच विरोध

मुंबई, दि. ८ (प्रतिनिधी) : केवळ अपवादात्मक परिस्थितीत म्हणजे 'आपत्ती व्यवस्थापन कायदा' किंवा 'साथरोग प्रतिबंधक अधिनियम' लागू केल्याने शाळा तीन महिने बंद ठेवाव्या लागल्यास खासगी शाळांच्या शुल्करचनेचे नियमन करण्याचे अधिकार राज्य सरकारला देणाऱ्या मूळ प्रस्तावाला मंत्रिमंडळातील शिक्षणसम्राट मंत्र्यांमुळे बगल द्यावी लागत आहे. कोरोनामुळे उत्पन्नवार परिणाम झालेल्या पालकांना दिलासा देण्यासाठी खासगी शाळांचे शुल्क १५ टक्क्यांनी कमी करता यावे, यासाठी 'महाराष्ट्र शैक्षणिक संस्था (शुल्क विनियमन) अधिनियम'त अध्यादेशद्वारे सुधारणा करण्याच्या शालेय शिक्षण विभागाच्या प्रस्तावाला मंत्रिमंडळ बैठकीत मान्यता देण्यात आली होती. त्यानुसार आपत्ती व्यवस्थापन कायदा किंवा साथरोग प्रतिबंधक अधिनियम लागू असल्यास आणि शाळा तीन महिन्यांहून

तलवार कायम राहणार आहे. मंत्रिमंडळातील जवळपास १७ ते १८ मंत्र्यांच्या स्वतःच्या शाळा-कनिष्ठ महाविद्यालये आहेत. गेल्या वर्षी शुल्क कमी करण्याबाबत सरकारने काढलेल्या सरकारी आदेशाला उच्च न्यायालयात आव्हान देण्यात यापैकी काही संस्थांचालक नेत्यांच्याच शाळा आघाडीवर होत्या. आताही खासगी शाळांच्या शुल्करचनेमध्ये अपवादात्मक परिस्थितीत हस्तक्षेप करण्याची कायमस्वरूपी तरतूद वाचून ती वर्षभरापुरती करण्याचा संस्थांचालक मंत्र्यांचा आग्रह आहे. या झारीतील शुक्राचार्यांमुळे ऑगस्ट उजाडला तरी शाळा शुल्काबाबत पालकांना दिलासा देण्यात राज्य सरकाराला यश आलेले नाही. खासगी शाळांच्या शुल्कासंदर्भात राज्याचे सध्याचे अधिकार फारच मर्यादित आहेत. त्यामुळे राजस्थान सरकार प्रकृती सर्वोच्च न्यायालयाने दिलेल्या निर्णयाच्या

आधारे पालकांना दिलासा देण्याचा प्रयत्न केला जाईल. या निकालात शुल्कात १५ टक्के कपात करण्याबरोबरच शुल्क न भरल्यास विद्यार्थ्याला ऑनलाईन किंवा तत्सम वर्गातून बेदखल करण्यापासून शाळांना रोखण्यासही न्यायालयाने मनाई केली आहे. अशा प्रकरणांमध्ये हस्तक्षेप करण्याचे अधिकारही या अध्यादेशामुळे राज्य सरकारकडे येतील. ज्या पालकांनी वर्षांच्या सुरुवातीलाच संपूर्ण सत्राचे वा वर्षांचे शुल्क भरले आहे, त्यांनाही या अध्यादेशाद्वारे दिलासा मिळू शकेल. हे अतिरिक्त शुल्क पुढील सत्रात किंवा वर्षात समायोजित करण्याचे आदेश सरकार देऊ शकते. इतर राज्यांमध्ये कोरोनामुळे नेकीरंधावर परिणाम झालेल्या पालकांना दिलासा देण्याकरिता खासगी शाळांच्या शुल्करचनेमध्ये त्या त्या सरकारने हस्तक्षेप केल्याचे दिसून येते.

सणासुदीला गर्दी करू नका म्हणणाऱ्या मोदींचीही राज्यातील भाजपा नेते ऐकत नाही - नवाब मलिक

मुंबई, दि. ८ (प्रतिनिधी) : कोरोनाचे संकट टाळण्यासाठी मुख्यमंत्री व पंतप्रधान नरेंद्र मोदी भूमिका घेत आहेत. मात्र, याला राज्यातील भाजपा नेत्यांकडून दुसरीकडे पंतप्रधान नरेंद्र मोदी सणासुदीला गर्दी होणार असल्याने चिंतेत आहेत. त्यांनी त्याचपध्दतीने काळजी घेण्याचे निर्देश राज्यांना दिले आहेत, असेही ते म्हणाले.

सुशांतसिंग राजपूतच्या केसमध्ये ही हत्या की आत्महत्या होती, हे सीबीआयने एक वर्ष झाले, तरी स्पष्ट केले नाही. याचा अर्थ हे महाराष्ट्र सरकारला बदनाम करण्याचे कटकारस्थान होते, असा थेट आरोप मंत्री नवाब मलिक यांनी केला आहे. सुशांतसिंग राजपूतच्या आत्महत्येचा तपास सीबीआयने ताब्यात घेऊन आज एक वर्ष पूर्ण झाले. मात्र, अजूनही यामध्ये सीबीआयने कोणताच खुलासा केला नाही, याबाबत शंका उपस्थित केली जात असल्याचेही ते म्हणाले.
