INDIAN BURST FIRECRACKERS on Sunday and offered prayers of gratitude over the election of Kamala Harris as the next US vice president, declaring it a proud moment for Indian-Americans.



Harris, born to an Indian mother and a Jamaican father, both of whom immigrated to the US to study, made history by becoming the first woman to win the second-highest US office.

Kamala Harris, who visited the village when she was five, has often recalled walks with her maternal grandfather on the beaches of Chennai

"At her ancestral Thamilnaduram village in Tamil Nadu, about 8,000 km from Washington DC, children clutched posters of Harris as people gathered at a temple to thank the gods for her and in present-elect Joe Biden's victory.
